



Dual-Plan options from LifeWise

The dual-plan options include health plans that:

- Give employees more control over how they spend their money on healthcare
- Provide them with tax-advantaged savings opportunities
- Offer them a range of affordability



Requirements

- Premium rates do not change when a Dual-Plan option is selected
- Must have at least eight employees enroll to implement a Dual-Plan option
- There is a minimum plan participation requirement of at least three employees enrolled on each plan
- The Hearing Vision Alternative (HVA) and Vision (V) riders are available—if selected, must be added to both plans
- The minimum employer contribution is based on the lowest-cost plan
